### 73th ANNUAL GENERAL MEETING

## 24 August 2017

#### **CHAIRMAN'S REPORT 2017:**

Welcome to the 73rd Annual General Meeting for Lung Health Auckland.

What I love most about being the Chairman of Lung Health is being part of an organization which offers assistance to patients with respiratory illnesses going through a difficult period. It gives me extreme satisfaction seeing the gratefulness expressed by the person being helped. Each one of us can help to contribute to people's lives in a positive way.

The Executive Committee, Bette Swan, Kathy Smith and Jenny Paynter have continued to meet monthly to review expenditure and requests for assistance. Once again, we have liaised with Roy Adams and Graeme McLeod via email to discuss our investment portfolio, and with Anthony Segedin for legal advice.

This year it feels like we have had to decline more referrals than usual due to the patient not having a significant Respiratory Illness. It is always difficult to say we can't help. If you have ever had a referral declined do not give up asking for help. We have tried to keep the process as easy as possible. It is important however that we honour our purpose, which is to help those with respiratory illnesses.

Lung Health Auckland is very versatile in how we assist patients. This means that our assistance is quickly available without long bureaucratic delays, and is tailored to that particular person's needs rather than being a "one size fits all" approach.

Requests for assistance now come from a wider range of health professionals, and this means that our assistance is reaching more of those who need help.

Patients have been helped in may ways, from providing food vouchers to buying heaters and paying for power to run the heaters. Sometimes a dehumidifier is more appropriate, and so, less frequently, we have provided one. We have provided means for patients to attend appointments through petrol vouchers, HOP cards and taxi chits.

Assistance to the Respiratory Ward Auckland City Hospital has been in the way of replacing TV's when the current TV is unable to be repaired and we have also provided 2 lazy boy chairs for patient use and replaced the microwave in Ward 72a. Lung Health has benefited by the Auckland

City Hospital now having internet access for patients, so we are no longer providing USB Modems to patients to enable internet access.

Other ways we have been able to help include providing warm clothes, helping with GP bills where needed, helping with rent, rates, St John ambulance bills, and dust mite covers for asthma patients. Lung Health also gave assistance towards attendance at conferences and study days for health professionals.

Every year Lung Health gives a little more assistance to one or two patients. This year we assisted a patient complete his course of TB treatment by giving petrol vouchers for goals met, and toward the end of his treatment paid for accommodation. We also assisted one patient through paying for child support.

Other activities Lung Health have been a part of include providing goodies for the Respiratory Ward patients at Easter and Christmas. Last Christmas we gave a \$40 food voucher and a Christmas cake for patients in need, instead of a food hamper. This seemed to work very well.

Once again Lung Health sponsored the afternoon tea for World TB Day in March. Thank you, Kathy Smith, for organising this event.

Our application to the Asser Trust dated 14 April 2016 for \$50,000 was finally approved on the 3 March 2017. The Asser trust has not make a call for submissions. Hopefully they will in the 2017/2018 period.

Lung Health over the years has held profit from TB Conferences to enable seeding grants to Conferences in the future. Hutt Valley is organising a TB Conference for 2018 and a seeding grant has been loaned to a value of \$10,000. Lung Health will also encourage and support nurses to attend this conference.

I wish to sincerely thank the following people for their ongoing support in keeping Lung Health Auckland a vibrant and functioning Charitable Trust helping 100's of people in Auckland with both Respiratory Illnesses and Tuberculosis:

- Bette Swan for her ongoing enthusiastic care for all requests for help. Often in her own time. Bette, you do an amazing job.
- The executive committee Bette Swan and Kathy Smith for their commitment to meeting monthly.


### **INCIDENCE OF TUBERCULOSIS THROUGHOUT NEW ZEALAND 2016**


