#### 75th ANNUAL GENERAL MEETING

## 22 August 2019

#### CHAIRMAN'S REPORT 2019:

Welcome to the 75th AGM for Lung Health Auckland. I think 75 years should be celebrated. I myself am proud to be a part of this organization and even more proud of what has been achieved during the past 75 years.

The Executive Committee, Bette Swan, Kathy Smith and Jenny Paynter have continued to meet monthly to review expenditure and requests for assistance. Martin Edwards sends monthly update of our investment portfolio, which appear to have done very well. Martin will explain the progress later in the meeting.

Once again Lung Health Auckland has assisted many respiratory patients in various ways. We have provided food vouchers, bought heaters and paid for power to run the heaters. We have provided means for patients to attend appointments by providing petrol vouchers, HOP cards and taxi chits.

Other ways that patients have been assisted include payment of St John membership or their account, purchase of taxi disability card, provision of mite guard covers for patients affected by asthma, payment of GP bills or provision of a credit at the GP so that patients do not miss GP appointments, incentives for exercise, and provision of warm bedding. Another way we help is to pay for prescriptions to ensure that the medications are picked up and thus used.

Assistance to the Respiratory Ward Auckland City Hospital has been in the way of replacing TV's remotes. These have now been secured to the bed lockers so they don't disappear in future.

Lung Health has been able to assist a young boy with TB. He comes from a very challenging background and is thriving despite all the challenges he has to face.

To encourage him Lung Health has paid for meals at school and topped up his HOP card regularly.

Taxis are still an important means for helping patients to clinic appointments. This is very helpful for patients attending pulmonary rehabilitation, who would find it very difficult to manage any sort of public transport.

I must once again thank the Public Health Nurses for their assistance in getting patients to and from the TB Clinic; this will have significantly reduced the cost of taxis.

Other activities Lung Health have been a part of, include providing goodies for the Respiratory Ward patients at Easter and Christmas. This year we gave a \$40 food voucher and a Christmas cake for patients in need last Christmas instead of a food hamper.

For World TB day this year Lung Health Auckland supported the nurses and Doctors, both at Public Health office and the Respiratory Ward Auckland City Hospital, as no formal meeting had been arranged.

I am pleased to announce that the Asser Trust has again called for submissions which closed on the 26 June 2019. We are still waiting to hear the decision from our application.

Lung Health Auckland is continuing to hold a \$10,000 seeding grant available for the next TB Conference in New Zealand. At this stage one has not been organised.

Lung Health continues to operate from Bette Swan's home, with additional documents retained in a storage facility. The transition to most bill payments being made via internet banking has been very successful, with the three members of the executive being the authorised signatories. We have continued to meet all statutory obligations with appropriate filings made to the Charities Commission and the Registrar of Incorporated Societies.

I wish to sincerely thank the following people for their ongoing support in keeping Lung Health Auckland a vibrant and functioning Charitable Trust helping 100's of people in Auckland with both Respiratory Illnesses and Tuberculosis.

Bette Swan for her ongoing enthusiastic care for all requests for help. Often in her own time. Bette you do an amazing job.

The executive committee Bette Swan and Kathy Smith for their commitment to meeting monthly.

To Anthony Segedin for your years of giving legal advice at no charge for many, many years. We thank you and wish you well in your retirement.

To the Public Health nurses who assist may of the TB patients to clinic appointments saving Lung Health Auckland the cost of transport.

To Jocelyn Dutton for promptly auditing the Lung Health Auckland's accounts

And to the members for without you we would not be able to meet the requirements of our charitable trust.






### **INCIDENCE OF TUBERCULOSIS THROUGHOUT NEW ZEALAND 2018**


